Notwithstanding any other provision in these Terms and Conditions, you and ChubbyTrader Pty Ltd agree that you both retain the right to bring an action in small claims court and to bring an action for injunctive relief or intellectual property infringement.

This data may be collected using the following methods:

# How We Use Personal Data

The data we collect automatically is used for the following purposes:

# Who We Share Personal Data With

# How Long We Store Personal Data
